**Mergers, Closures, and Institutional Changes as of 2017:Q1**

1/1/2017 - Polonia Bancorp Inc., and its subsidiary Polonia Bank, were acquired by Prudential Bancorp Inc. Polonia Bank was merged into Prudential's commercial bank subsidiary, Prudential Bank.

2017Q1 - HV Bancorp Inc., the holding company for Huntingdon Valley Bank, was established.

2017Q1 - Monument Bancorp Inc., the holding company for Monument Bank, was established.

2017Q1 - Crown Bank is under the responsibility of the Federal Reserve Bank of New York and no longer on the Third District institution list.

**Mergers, Closures, and Institutional Changes as of 2017:Q2**

2017Q2 - First National Bank of Mifflintown changed its name to Pennian Bank.

**Mergers, Closures, and Institutional Changes as of 2017:Q3**

2017Q3 - Wallkill Valley Bancorp MHC became a federal mutual holding company. Wallkill Valley Bancorp Inc. (Walkill) became a savings and loan holding company by acquiring 100% of New York-based Wallkill Valley Federal Savings and Loan Association. The Third District has supervisory oversight of the institution. In addition, Walkill acquired Hometown Bancorp MHC and Hometown Bancorp Inc. (MHC) on August 11, 2017

9/15/2017 - Bucks County Bank was acquired by First Bank. Bucks County Bank remains a separate subsidiary of First Bank.

9/30/2017 - PDL Community Bancorp (PDL) converted to a SLHC. Additionally, Ponce De Leon Bank was rebranded as Ponce Bank. The Third District has supervisory oversight of the institution.

**Mergers, Closures, and Institutional Changes as of 2017:Q4**

10/1/2017 - Chelton Hills Savings Bank was acquired by Penn Community Financial Corp. The savings bank subsidiary was merged into the bank subsidiary, Penn Community Bank.

10/1/2017 - CBT Financial Corp., and its subsidiary CBT Bank, were acquired by Riverview Financial Corp. CBT Bank was merged into Riverview's bank subsidiary, Riverview Bank.

10/1/2017 - Astoria Financial Corp., and its subsidiary Astoria Financial, were acquired by Sterling Bancorp. Astoria Financial Corp. remains a separate subsidiary of Sterling Bancorp.

12/15/2017 - Royal Bancshares of PA Inc., and its subsidiary Royal Bank America, were acquired by Bryn Mawr Bank Corp. Royal Bank America was merged into Bryn Mawr's commercial bank subsidiary, Bryn Mawr Bank and Trust Co.

2017Q4 - Century BC dissolved its mid-tier holding company and is now the parent of Century Savings Bank.

**Mergers, Closures, and Institutional Changes as of 2018:Q1**

1/31/2018 - Sun Bancorp, Inc., and its subsidiary Sun National Bank, were acquired by OceanFirst Financial Corp. OceanFirst Financial Corp. converted to a bank holding company due to the conversion of OceanFirst Bank to a national commercial bank from a federal savings bank. Sun National Bank will function as a division of OceanFirst Bank NA until the integration of operating systems, which is expected to be completed in June.

2/12/2018 - Malvern Federal Savings Bank converted to a national bank and will operate as Malvern Bank NA. Additionally, the bank's parent, Malvern Bancorp Inc., will be registered as a bank holding company.

3/1/2018 - Liberty Bell Bank was acquired by Delmar Bancorp. The bank was merged into the bank subsidiary, Bank of Delmarva.

3/26/2018 - Wawel Financial Services (MHC), and its subsidiary Wawel Bank, were acquired by Spencer Savings Bank SLA. Wawel Bank will function as a division of Spencer Savings Bank until the integration of operating systems, which is expected to be completed in July.
