Mergers, Closures, and Institutional Changes as of 2016:Q3
2016Q2 - Synchrony Financial, and its subsidiary bank Synchrony Bank, were added to the SLHC list. The Third District has supervisory oversight of the institution.
7/1/2016 - Harmony Bank was acquired by Lakeland Bancorp. Harmony Bank was merged into Lakeland Bancorp's commercial bank subsidiary, Lakeland Bank.
7/1/2016 - Fox Chase Bancorp, Inc., and its subsidiary Fox Chase Bank, was acquired by Univest Corp. of Pennsylvania (Univest). Fox Chase Bank was merged into Univest 's commercial bank subsidiary, Univest Bank.
7/13/2016 - FSB Community Bankshares MHC converted to a stock bank holding company. As a result, the Federal Reserve Bank of New York has supervisory oversight of the institution.
8/15/2016 - Penn Liberty Financial Corp. (Penn Liberty), and its subsidiary bank Penn Liberty Bank, were acquired by WSFS Financial Corp. Penn Liberty was merged into WSFS Financial's savings bank subsidiary, WSFS Bank.
Mergers, Closures, and Institutional Changes as of 2016:Q4
2016Q4 - Penn Liberty Financial Corp. (Penn Liberty), and its subsidiary bank Penn Liberty Bank, were acquired by WSFS Financial Corp in 2016Q3. Although the bank was merged into WSFS Financial's savings bank subsidiary, the BHC was not dissolved until 2016Q4.
11/30/2016 - Ocean Shore Holding Co., and its subsidiary bank Ocean City Home Bank, was acquired by OceanFirst Financial Corp. Until the expected completion of the integration of the operating systems in the spring of 2017, Ocean City Home Bank will operate as a division of OceanFirst Bank until the full integration of the operating systems is completed.
11/7/2016 - East River Bank completed its conversion into DNB First NA after the closing of East River Bank's acquisition by Downingtown, Pa.-based DNB Financial Corp. on Oct. 1. The conversion included systems integration and rebranding of three Philadelphia-based branches.
12/2/2016 - First Choice Bank was acquired by Berkshire Hills Bancorp, Inc. (Berkshire). First Choice Bank was merged into Berkshire's commercial bank subsidiary, Berkshire Bank.
Mergers, Closures, and Institutional Changes as of 2017:Q1
1/1/2017 - Polonia Bancorp Inc., and its subsidiary Polonia Bank, were acquired by Prudential Bancorp Inc. Polonia Bank was merged into Prudential's commercial bank subsidiary, Prudential Bank.
2017Q1 - HV Bancorp Inc., the holding company for Huntingdon Valley Bank, was established.
2017Q1 - Monument Bancorp Inc., the holding company for Monument Bank, was established.
2017Q1 - Crown Bank is under the responsibility of the Federal Reserve Bank of New York and no longer on the Third District institution list.
Mergers, Closures, and Institutional Changes as of 2017:Q2
2017Q2 - First National Bank of Mifflintown changed its name to Pennian Bank.
Mergers, Closures, and Institutional Changes as of 2017:Q3

2017Q3 - Wallkill Valley Bancorp MHC became a federal mutual holding company. Wallkill Valley Bancorp Inc. (Walkill) became a savings and loan holding company by acquiring 100% of New York-based Wallkill Valley Federal Savings and Loan Association. The Third District has supervisory oversight of the institution.

In addition, Walkill acquired Hometown Bancorp MHC and Hometown Bancorp Inc. (MHC) on August 11, 2017

9/15/2017 - Bucks County Bank was acquired by First Bank. Bucks County Bank remains a separate subsidiary of First Bank.

9/30/2017 - PDL Community Bancorp (PDL) converted to a SLHC. Additionally, Ponce De Leon Bank was rebranded as Ponce Bank. The Third District has supervisory oversight of the institution.
